STATE OF MONTANA - FISCAL NOTE

Fiscal Note for HB0312, as introduced

DESCRIPTION OF PROPOSED LEGISLATION:

An act requiring that a voter registration form be made available at the time of application for a license from the Department of Fish, Wildlife and Parks, from department wardens, or from license agents for the department.

ASSUMPTIONS:

1. Secretary of State will provide registration forms to the Department of Fish, Wildlife and Parks (FWP) sufficient to meet the obligations of this act.
2. FWP has 495 license agents and wardens in Montana.
3. One hundred cards per agent, per year would be made available by the Secretary of State to FWP for distribution with their regular mailings to license agents and wardens (a total of 49,500 cards per year).
3. Marginal printing cost for the Secretary of State to print additional cards of this amount is \$1,500 per year (based on bid from Artcraft Printers).
4. FWP will absorb the marginal cost for distributing the voter registration forms.
