Fiscal Note for HB0334, as introduced

DESCRIPTION OF PROPOSED LEGISLATION:

A bill for an act eliminating the regulation of flour and bread by the Department of Health and Environmental Sciences.

ASSUMPTIONS:

1. These statutes duplicate the flour and bread enrichment standards adopted by reference under the Montana Food, Drug, and Cosmetic Act contained in Title 50, Chapter 31, MCA, with the federal standards updated annually for interstate commerce consistency.
2. There will be no fiscal impact with elimination of these statutes, since any necessary staffing and expenditures addressing flour and bread enrichment standards are contained in the Montana Food, Drug, and Cosmetic program.
