9 NEW SECTION. Section 1. Pinochle tournaments. (1) Subject to the department's approval, a
10 person or entity is entitled, upon submission of a permit application and payment of a \$50 fee, to a permit
11 for sponsoring a pinochle tournament. A person or entity is entitled to only one permit in each calendar
12 year. The department shall retain the fee for administrative purposes. The tournament may be conducted
13 for no more than 3 consecutive days and may be conducted at one or more premises.

14 (2) Tournament participants must be provided with a copy of the tournament rules before the start
15 of the tournament. A copy of the rules must be posted in a conspicuous location in each area and premises
16 where the tournament is conducted. A person must be present on the premises during the tournament to
17 oversee the conduct of the card games and to settle disputes among players.

18 (3) A tournament sponsor may charge a tournament participant an entry fee, which may include
19 a fee to cover expenses incurred in conducting the tournament.

NEW SECTION. Section 1. Pinochle tournaments. (1) Subject to the department's approval, a ~~person or entity~~ NONPROFIT ORGANIZATION is entitled, upon submission of a permit application and payment of a ~~\$50~~ \$25 fee, to a permit for sponsoring a pinochle tournament. A ~~person or entity~~ NONPROFIT ORGANIZATION is entitled to only one permit in each calendar year. The department shall retain the fee for administrative purposes. The tournament may be conducted for no more than 3 consecutive days and may be conducted at one or more premises.
