### STATE OF MONTANA - FISCAL NOTE

Fiscal Note for HB0575, as introduced

## DESCRIPTION OF PROPOSED LEGISLATION:

An act generally revising the law regarding the administration, goals, and budget prioritization of the Fisheries Division of the Department of Fish, Wildlife and Parks (FWP); establishing the Fisheries Management Trust account; appropriating a portion of general license revenue, certain money dedicated under the Future Fisheries Improvement Program (FFIP), and certain capital improvement funds to the Future Fisheries Management Trust account; directing that the interest on money in the account be expended for the enhancement of Montana's fisheries and allowing the account to be used as bond security for the Future Fisheries Improvement Program; and providing an effective date.

## ASSUMPTIONS:

- 1. HB349 as introduced will pass and become law.
- 2. The \$2.5 million for the Bluewater Hatchery and the \$230,000 for the Fish Health Lab as contained in the Long-Range Building Program (LRBP) will be redirected to accommodate the intent of this bill. \$2.0 million will be appropriated to the Future Fisheries Improvement Program (FFIP), \$500,000 will be redirected to the Miles City warm water hatchery, and \$230,000 will be redirected to Montana State University at Bozeman for fishery laboratory facilities. The fish laboratory is to be made available to the Department of Fish, Wildlife and Parks for routine fish testing as well as for general fish research.
- 3. The bill establishes the Fisheries Management Trust account, \$3.5 from the FWP general license account FYE94 balance and 10% of \$4,978,940, the minimum amount dedicated annually to the FFIP under HB349, are directed to be deposited in the trust account.
- 4. There will be no additional revenues, just a redistribution of existing revenues.

# FISCAL IMPACT:

A Fisheries Management Trust account will be created with \$3.5 million from the Department of Fish, Wildlife and Parks general license account FYE94 balance and a projected \$497,894 which is 10% of the minimum amount dedicated annually to the Future Fisheries Improvement Program under HB349.

Redirecting the \$3.5 million from the general license account FYE94 balance could necessitate a license increase.

The capital project proposals will be impacted by the redirection of fishery activities.

### LONG-RANGE EFFECTS OF PROPOSED LEGISLATION:

The direction of the Montana fisheries program will change with emphasis on the Future Fisheries Improvement Program as provided for in this bill and HB349, and the Fisheries Management Trust program, which will impact the capital project budget.
