12 **NEW SECTION. Section 1. Authorization of bonds.** (1) The board of examiners is authorized to  
13 issue and sell general obligation long-range building program bonds in an amount not exceeding \$2,193,617  
14 for the law enforcement academy project over and above the amount of general obligation long-range  
15 building program bonds outstanding on January 1, 1995, to be issued in accordance with the terms and  
16 in the manner required by Title 17, chapter 5, part 8. The authority granted to the board by this section  
17 is in addition to any other authorization to the board to issue and sell general obligation long-range building  
18 program bonds. The bond proceeds are appropriated for the project.

19 (2) The law enforcement academy project consists of improvements or the planning, capital  
20 construction, renovation, furnishing, or major repair of the Mountain View school in Helena, Montana.

22 **NEW SECTION. Section 2. Planning and design.** The department of administration may proceed

Authorization of bonds.** (1) The board of examiners is authorized to issue and sell general obligation long-range building program bonds in an amount not exceeding \$2,193,617 for the law enforcement academy project over and above the amount of general obligation long-range building program bonds outstanding on January 1, 1995, to be issued in accordance with the terms and in the manner required by Title 17, chapter 5, part 8. The authority granted to the board by this section is in addition to any other authorization to the board to issue and sell general obligation long-range building program bonds. The bond proceeds are appropriated for the project. **APPROPRIATION.** (1) THERE IS APPROPRIATED TO THE DEPARTMENT OF ADMINISTRATION FOR THE LAW ENFORCEMENT ACADEMY PROJECT A TOTAL OF \$1,450,000, OF WHICH \$950,000 IS FROM THE LONG-RANGE BUILDING PROGRAM ACCOUNT AND \$500,000 IS FROM LEWIS AND CLARK COUNTY.
