DESCRIPTION OF PROPOSED LEGISLATION:

An act granting the state the right to a jury trial in all felony and misdemeanor cases in all courts.

FISCAL IMPACT:

Passage of SB10 will have no fiscal impact on state government.

EFFECT ON COUNTY OR OTHER LOCAL REVENUES OR EXPENDITURES:

Some fiscal impact, though perceived minimal and estimated to average one jury trial per year, will be experienced by local governments due to jury costs.
