9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 53-2-1110, MCA, is amended to read:

12 **"53-2-1110. Review of job training plans.** At least 120 days before the beginning of the first of
13 the 2 program years covered by the job training plan, the governor shall submit the proposed job training
14 plan for review and comment to an appropriate standing committee of each house of the legislature, as
15 required by 29 U.S.C. 1515, or, if the legislature is not in session, the governor shall submit one copy of
16 the proposed job training plan to an appropriate interim committee designated by the speaker of the house
17 of representatives, and one copy to the president of the senate, and one copy to the legislative council."

19 **NEW SECTION.** **Section 2. Coordination instruction.** [This act] is void if House Bill No. 2 is passed
20 and approved and contains provisions allocating to the legislative council for the activities of the interim
21 committee described in 53-2-1110 funds appropriated to the department of labor and industry from federal
22 special revenue from the Job Training Partnership Act.

NEW SECTION. **Section 3. Effective date.** [This act] is effective on passage and approval.

STATE OF MONTANA - FISCAL NOTE

Fiscal Note for SB0016, as introduced

DESCRIPTION OF PROPOSED LEGISLATION:

An act eliminating review by a special legislative committee of the state job training plan required by the federal Job Training Partnership Act (JTPA).

ASSUMPTIONS:

1. There will be no funds appropriated in the general appropriations act (HB2) from the general fund or from JTPA federal special revenue to fund the activities of the JTPA Review Committee. The Legislative Council's budget request in the Governor's Executive Budget for the 1997 biennium includes \$4,602 in general fund for the operation of the JTPA Review Committee; it is assumed that this amount will be removed from HB2 at the request of the Legislative Council if this bill is passed and approved. The general fund reduction shown below will not be realized until the amount is deleted from HB2.
2. SB16 contains coordination instructions that this bill is void if HB2 is passed and approved with federal special revenue funds allocated to the Legislative Council from the Department of Labor and Industry attributable to JTPA. Such an allocation is not included in the Governor's Executive Budget or the introduced version of HB2. Therefore, it is assumed that the coordinating provision will not come into effect.
3. Upon passage and approval of this bill, the legislature will have no formal mechanism or procedure for reviewing the state job training plan other than assignment to an appropriate standing committee of each house. Consequently, there will be no significant additional costs incurred for legislative review.
