## DESCRIPTION OF PROPOSED LEGISLATION:

An act including greyhound races as races that may be simulcast under the Board of Horse Racing's authority.

## ASSUMPTIONS:

- 1. The bill would be effective on passage for planning purposes and implemented by the agency July 1, 1995.
- 2. There will be network simulcasts Friday and Saturday evenings during the winter simulcast season (October through May) of approximately 75 days.
- 3. Greyhound races will produce an additional average daily gross receipts (handle) of \$15,000 X 75 days generating a \$1,125,000 annual handle. One percent of the handle, or \$11,125, will be credited to Board of Horse Racing state special revenue account.
- 4. Any cost adjustments will be absorbed into the Board of Horse Racing current level budget.
