STATE OF MONTANA - FISCAL NOTE

Fiscal Note for SB0076, as introduced

DESCRIPTION OF PROPOSED LEGISLATION:

A bill that makes permanent the Joint Committee on Postsecondary Education Policy and Budget.

ASSUMPTIONS:

1. The Office of the Legislative Fiscal Analyst will provide for staff support and expenditures of the joint committee.
2. Eight one-day meetings will be held during the 1997 biennium.
3. The estimated expenditures will be \$1,850 per meeting for a total general fund cost of \$14,800 for the 1997 biennium. The fiscal impact assumes equal expenditures in each year of the biennium although the actual distribution depends upon when meetings are held.
4. Travel and per diem costs are based upon the current joint committee membership with the assumption that new members would incur, and be reimbursed for, the same level of costs.
5. There will be no fiscal impact to the Office of the Commissioner of Higher Education as the regents' costs will be paid by the Office of the Legislative Fiscal Analyst.
