9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11       **Section 1.** Article II, section 14, of The Constitution of the State of Montana is amended to read:

12       **"Section 14. Adult rights.** A person 18 years of age or older is an adult for all purposes, except that

13       the legislature or the people by initiative may establish the legal age for gambling or for purchasing,

14       consuming, or possessing alcoholic beverages."

16        **NEW SECTION.** **Section 2. Submission to electorate.** This amendment shall be submitted to the  
17        qualified electors of Montana at the general election to be held in November 1996 by printing on the ballot  
18        the full title of this act and the following:
