## Fiscal Note for SB0268, as introduced

## DESCRIPTION OF PROPOSED LEGISLATION:

An act revising the restrictions on operating a snowmobile without a Montana driver's license by allowing the operation by a person who has completed an approved snowmobile safety education program and who is accompanied and supervised by a person who is 18 years of age or older.

## ASSUMPTIONS:

- 1. The Department of Fish, Wildlife and Parks provides a snowmobile safety education program through volunteer instructors.
- 2. Approximately 500 students per year will participate in this program state wide, and receive successful completion certificates.

FISCAL IMPACT:

Materials, training, and promotional costs will amount to \$10,000 per year and will be supported with snowmobile fuel tax funds.
