STATE OF MONTANA - FISCAL NOTE

Fiscal Note for HB0091, as introduced

DESCRIPTION OF PROPOSED LEGISLATION:

An act removing the sunset provision on the committee on public employee retirement systems (CPERS); repealing section 9, chapter 549, laws of 1993; and providing an immediate effective date.

ASSUMPTIONS:

1. The CPERS will hold five one-day meetings during the 1999 biennium at a cost of \$1,282 per meeting.
2. Committee printing costs and miscellaneous operating expenses will total \$9,590.
3. Meetings would begin after July 1, 1997.
4. No budget for CPERS was included in the fiscal 1998 and 1999 Legislative Branch budget request.
5. There is no fiscal impact on the retirement systems from this bill because the biennial appropriation of \$13,800 (enacted by the 1993 Legislature) ends on June 30, 1997, and no further appropriation is included in HB91.



TECHNICAL NOTES:

1. HB90 is a companion bill to HB91. If both HB90 and HB91 are passed and approved, the appropriation in HB90 is sufficient to cover the costs of the activities of the Committee on Public Employee Retirement Systems.
2. If this bill is passed and approved, but HB90 is not, an amendment or coordination instruction is necessary that appropriates \$16,000 general fund to the Interim Committees and Activities Program within the Legislative Services Division.
