1	HOUSE JOINT RESOLUTION NO. 1
2	INTRODUCED BY KITZENBERG
3	
4	A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF
5	MONTANA URGING LANDOWNERS, OUTFITTERS, THE SPORTING COMMUNITY, AND THE PUBLIC TO
6	WORK TOGETHER TO ADDRESS COMMON GOALS TO ENHANCE THE EFFICIENT MANAGEMENT OF
7	MONTANA'S WILDLIFE RESOURCES, INCLUDING POTENTIAL REORGANIZATION OF THE FISH, WILDLIFE,
8	AND PARKS COMMISSION AND THE DEPARTMENT OF FISH, WILDLIFE, AND PARKS; AND REQUESTING
9	THAT THESE EFFORTS BE COORDINATED THROUGH THE OFFICE OF THE GOVERNOR.

11	WHEREAS, the efficient operation of state wildlife agencies is in the best interests of Montana's
12	wildlife resources, Montana landowners, the outfitting industry, the sporting community, and the genera
13	public; and
14	WHEREAS, a goal of government reorganization is the efficiency and responsiveness of public
15	agencies as well as potential cost savings; and
16	WHEREAS, it is an appropriate aspect of recent government reorganization efforts to examine the
17	powers and duties of the Fish, Wildlife, and Parks Commission and the Department of Fish, Wildlife, and
18	Parks and the role and operation of those governmental entities, with a view toward the most efficient
19	responsive operation of those entities in the most cost-effective manner.
20	
21	NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
22	STATE OF MONTANA:
23	That landowners, outfitters, the sporting community, and the general public be strongly urged to
24	work together in a sustained, cooperative, and positive manner to study the role and operation of the Fish
25	Wildlife, and Parks Commission and the Department of Fish, Wildlife, and Parks and to examine the
26	following issues regarding those governmental entities:
27	(1) whether the Director of the Department of Fish, Wildlife, and Parks should be hired by and
28	retained at the discretion of the Fish, Wildlife, and Parks Commission rather than appointed by the
29	Governor;
30	(2) the appropriate number of members on the Fish, Wildlife, and Parks Commission;

1	(3) whether Commission districts should be reorganized to coincide with Department administrative
2	regions;
3	(4) appointment of an executive secretary for the Fish, Wildlife, and Parks Commission;
4	(5) the role, powers, and scope of the Fish, Wildlife, and Parks Commission; and
5	(6) other issues considered appropriate for the efficient, responsive operation of the Fish, Wildlife,
6	and Parks Commission and the Department of Fish, Wildlife, and Parks in the most cost-effective manner,
7	to the benefit of Montana's wildlife resources.
8	BE IT FURTHER RESOLVED, that the Office of the Governor be requested to coordinate these issues
9	by establishing an appropriate working group to develop mutually satisfactory solutions and that the
10	working group be representative of all Montana geographic regions and consist of:
11	(1) one member of the Fish, Wildlife, and Parks Commission;
2	(2) two representatives of landowners or the agricultural industry;
13	(3) two representatives of the outfitting industry;
14	(4) five representatives of Montana sporting groups;
15	(5) two representatives of state government, including one state senator and one state
16	representative; and
17	(6) at least one member of the general public.
18	BE IT FURTHER RESOLVED, that the Department of Fish, Wildlife, and Parks be encouraged to
19	provide administrative assistance as necessary to enhance the cooperative effort.
20	BE IT FURTHER RESOLVED, that solutions developed by the working group be reported to the
21	Governor and to future legislatures and that any suggested legislation reflect the mutual interests of
22	landowners, outfitters, and the sporting community, to the benefit of Montana's wildlife resources.
23	BE IT FURTHER RESOLVED, that the Secretary of State send copies of this resolution to any
24	landowner, agricultural, outfitter, sporting, or other group or organization that is interested or involved in
25	the issues outlined in this resolution, including but not limited to the Montana Stockgrowers Association
26	Montana Wildlife Federation, Montana Wool Growers Association, Montana Farm Bureau, Montana
27	Outfitters and Guides Association, Montana Audubon Council, Montana Trout Unlimited, Walleyes Unlimited
28	of Montana, Montana Sport Hunting Coalition, Montana Hunters Alliance, Rocky Mountain Elk Foundation
