

Timeline of Significant Events, Milestones, and important activities related to Montana's Pilot Pretrial Project 2017-Present

April 2017

***House Bill 59 passed by the Montana Legislature and provided funding to establish pilot projects. (3-7-208 MCA).**

- Introductory meeting with Chief Justice McGrath, Court Administrator Beth McLaughlin, Becky Busaka, Mike Ferriter, Pam Bunke. Meeting included discussion of project objectives and potential pilot counties.
- Discussed milestones reviewed outline provided by the court
- Pretrial University attendance by Pam for six weeks
- Initialed work on policy and procedures
- Pam Bunke enrolls and complete training via “Pretrial University”

May 2017

- It was determined that the project would review three pretrial assessments, Colorado's, Virginia's, and the public Safety Assessment (PSA) for possible use in Montana
- Project task list developed
- Initial contact with LJAF (Arnold Foundation) and started communicating electronically with LJAF representative Virginia Bersch
- Project focused on the Public Safety Assessment (PSA) instrument, due to ease of use, no staff required for interviews, evidence/research. I am supporting the value of the instrument.
- Conference call with Virginia Bersch regarding LJAF accepting Montana as a PSA site
- Determined need for letters of support from key stakeholders to LJAF to accept Montana
- It was determined that an alternative to gain the support from LJAF was to pay \$300,000 to Utah company to develop an assessment interest for Montana
- Letters of support from key stakeholders including the chief Justice, Governor, and Legislators, received and send to LJAF.
- Chief Justice McGrath provided initial goals for the project. The goals included getting the project started as soon as possible and to ensure we utilize an instrument that is evidence based.
- Chief Justice McGrath indicated that the counties of Missoula, Yellowstone, Lake, Lewis and Clark and possibly Butte/Silverbow be considered for the project. His suggestion was based on jail population issues as well as counties experiencing large court backlog.

June 2017

- Project staff completes six-week training via “Pretrial University: on a variety of topics including: Legal foundations of pretrial, Risk Assessments, Pretrial Justice/History of pretrial and Risk Management and Effective Bail Hearings

July 2017

- Budget is developed and roles of project managers clarified.
- Statutory required Advisory Committee is appointed by Chief Justice McGrath Advisory Council selection by Chief Justice and Court Administrator completed on 7-12-17 with the following

selection:

-Judge Salvagni, Chairman, Judge Gustafson, Judge Halloway, State Representative Patelis, County Attorney Twito, State Senator Wolken, Sheriff Dutton and Public Defender Administrator Freeborn

August 2017

- Missoula County Stakeholders meeting

- LJAF consultants present implementation plan to Advisory Board
- Fact sheet for PSA developed

- MOU signed with LJAF now known as Arnold Ventures
- Business model downloaded into software to perform PSA
- Wrote vision, objectives, and mission statement for PTS

November 2017

- Working Committee met on two separate occasions to continue work on “violence list” and work on Decision Making Framework (DMF) and gain information on the AutoMon system.
- Deployment of plan including decision related to pilot counties and contractors
- Plan solidified for judges training and county staff
- Discussion related to data collection and project outcome measure
- Start of work related to project policies and procedures
- Montana violence definition determined

- Found room for processors
- Ordered CJIN terminals
- Ordered processor equipment
- Wrote position description for processors
- Posted position description
- Drafted interagency agreements for pilot counties

- Advisory Committee met in Bozeman. Work related to the DMF presented by members of Working Committee, legislature talking points addressed

April 2018

- Developed budget narrative for pilots
- Testing PSA
- Hiring processors started for processors
- Lake went live with PSAs

- Missoula went live with PSAs
- BSB went live with PSAs
- L&C went live with PSAs

June 2018

- Advisory committee met in Bozeman
- Yellowstone went live with PSAs

October 2018

- Decision Making Framework (DMF) revised to eliminate level “0”. Change approved by both Working and Advisory Committees
- New members appointed to Advisory Committee. Advisory Committee members include Leo Dutton, Alex Beal, Nate McConnell, Michael Moses, Barry Usher, Rhonda Schaffer, Scott Twito and Chair Mike Salvagni
- Criteria developed for performing PSA.
- Violence list determined
- Drafted PMR

November 2018

- Preliminary pretrial project data analysis completed
- Advisory Committee met in Butte to review data. Consultants present project recommendations and finalize their role with project.

December 2018

- Working Committee met to discuss consultant's project recommendations.

January 2019

- Consultant's report finalized and adopted
- Draft working "timeline" developed from consultant's recommendations. Timeline to serve as foundation for project strategic planning.
- 2019 Montana Legislature convenes. HB 110 is presented to legislature extending pretrial project and clarifies that the project has the authority to conduct assessments on both felony and misdemeanor offenses.
- Court Administrator's office requests funding for project at same level as in 2017.

April 2019

- 2019 Montana Legislature ends
- HB 110 and pretrial project funding both approved by legislature and governor

May 2019

- Supreme Court Administrator Beth McLaughlin prepares and provides memorandum to pretrial project stakeholders outlining outcomes of the 2019 legislature. Memorandum includes data shared with the 2019 legislature and expectations for the project in preparation for the 2021 Montana legislature.
- Working Committee reappointed, committee members include Lisa Eretz, Kellie McBride, Kelly Speer, Joel Thompson, Alex Hall, Jason Marks, James Lapotka, Eldena Bear Don't Walk, Ben Pezdark, Leo Gallagher and Alan Hughes
- Working Committee met via conference call

June 2019

- Public Defender Training takes place in both Billings and Missoula. Training provided by Scott West, Public Advocate for the Kentucky Department of Public Advocacy
