REQUEST FOR HEARING ON MATERIAL INJURY

In compliance with Case Management Order #5 issued by the Water Court on January 31, 2025, I, Linda Sauer, am responding to the Court's request for information pertaining to an evidentiary hearing and discovery.

My amended objection is dated December 7, 2023, and is Docket No. 1494.

I respectfully request that the Court hold an evidentiary hearing to provide evidence helpful in the determination of the extent of material injury, constitutional violations and violation of res judicata caused by the implementation and enforcement of the consent decree. I wish to provide this evidence not only in my personal interest but also as a matter of Public Interest.

It is my intention also to provide affidavits attesting to the details of material injury caused to Public Interest by the implementation of the Compact. I would like to reserve the right to call no more than two witnesses in lieu of the affidavits. I believe that presentation of my evidence and the possible witness testimony would take less than one hour.

I respectfully reserve the right to request discovery of the compact parties if necessary for the purpose of proving material injury, including, but not limited to, affirmations, interrogatories, and document production including the Damages Report, quantification of the water rights awarded to the CSKT in the Compact, and documents pertaining to the tribes' Court of Claims and Indian Claims Commission cases.

I would prefer to attend an evidentiary hearing in Lake County, but there are no dates or locations that would be impossible for me to attend.
