**ORDER APPROVING STIPULATION AND DISMISSING OBJECTION**

On November 21, 2022, Daniel L. Kain (“Kain”) filed a Notice of Objection and Request for Hearing. (Doc. 72.00). The filing sets forth Kain’s objections to the Confederated Salish and Kootenai Tribes – Montana – United States Compact now pending before the Water Court.

On July 14, 2023, the Confederated Salish and Kootenai Tribes, the State of Montana, and the United States of America on behalf of the Tribes (collectively, the “Compacting Parties”), and Kain filed a Stipulation of Withdrawal of Objection and Statement of No Call by the Confederated Salish and Kootenai Tribes of the Flathead Reservation, State of Montana, and United States (“Stipulation”). (Doc. 1,272.00).

The Stipulation sets forth the terms of an agreement under which the Compacting Parties and Kain contractually agree to resolve Kain’s objection. Pursuant to its authority under Rule 17, W.R.Adj.R. Under Rule 17(a) and § 85-2-233(5)(b), MCA, the Court accepts the Stipulation and finds it provides good cause to dismiss Kain’s objection.

**ORDER**

Therefore, it is ORDERED that the Stipulation is APPROVED, the objection filed by Kain is DISMISSED, and Kain is removed from the Master Service List for this case.
