CLARIFICATION ORDER

On August 29, 2023, Counsel for M & K Distributing LLC, Katherine Ann Noland Trust, and Flathead Janitorial & Rug Service Inc. filed a Motion for Clarification with the Court. (Doc. 1,321.00).

On August 25, 2023, the Court issued the Fifth Order Dismissing Objections and Updating Service List. (Doc. 1,616.00). As part of the Order, the Court notified several attorneys who inaccurately filed either Notices of Appearance or Substitutions of Counsel. The purpose of the notice was to indicate the filings were incorrect -- although the Court accepted them -- and to provide notice to the parties who may not have received proper notice as required by Section 4 of Case Management Order No. 2 and Uniform District Court Rule 10(e).
