**EIGHTH ORDER DISMISSING OBJECTIONS**

On October 2, 2023, the Court issued an Order to Show Cause (“Show Cause Order”). (Doc. 1,372.00). By cross-reference to the Final Mediation Report (Doc. 1,366.00), the Show Cause Order identified those parties who failed to participate in the Court-ordered mediation process. In prior case management orders, the Court provided notice it would dismiss the objections filed by parties who did not participate in any of the mediation conferences. The Court's October 2, 2023 Order identified non-participating parties and provided them an opportunity to show cause why their objections should not be dismissed. The deadline for responses was October 17, 2023.

The Court received five responses to the Show Cause Order. On October 13, 2023, objector Joseph A. Motta (“Motta”) filed a response. (Doc. 1,387.00). Motta filed objections on November 28, 2022 (Doc.139.00) and December 5, 2022 (Doc. 358.00). Motta’s response states he was unable to attend mediation conferences due to mail forwarding issues and with notices sent to a different party with the name “Motta.” Motta states he received a voicemail message and contacted the mediator to explain his situation.

On October 16, 2023, objector Barbara J. Bartell (“Bartell”) filed a response. (Doc. 1,390.00). Bartell filed an objection on December 2, 2022. (Doc. 248.00). Bartell’s response states she was not able to attend in-person mediations due to health issues. She also states she attempted to access online mediation sessions, but was unable to connect due to technical difficulties and unfamiliarity with the system.

On October 16, 2023, objectors Dwayne and Daphne Hofschulte filed a response in their individual capacities and in their capacity as managers for the entity Sage Country, LLC (collectively, “Hofschulte”). (Doc. 1,391.00). Hofschulte filed objections on January 25, 2023. (Doc. 530.00, 531.00, 532.00, and 533.00). Hofschulte’s response states they submitted a change of address form to the USPS, which was not timely processed, and which caused them to not receive notice. They switched to electronic filing and intended to participate remotely at a Zoom mediation, but inadvertently missed their designated time slot due to a computer glitch that incorrectly failed to update their time zone so they missed the designated mediation time.

On October 16, 2023, objector Michael L. Alexander (“Alexander”) filed a response. (Doc. 1,392.00). Alexander filed an objection on February 7, 2023. (Doc. 758.00). Alexander’s response states an attempt was made to travel to Missoula to attend an in-person mediation, but received incorrect information from a third party as to the mediation start time, so missed the opportunity.

On October 17, 2023, Rich Cary emailed a response directly to the Mediator. The response evidently was sent on behalf of the Richard C. Cary Trust (“Cary Trust”). The Mediator responded to the email with instructions stating all filings must be made with the Court. The Cary Trust filed its response with the Court on October 18, 2023. (Doc. 1,393.00). The filing includes the chain of correspondence documenting an attempt to file prior to expiration of the deadline in the Show Cause Order. The Cary Trust filed an objection on February 9, 2023. (Doc. 1,013.00). The Cary Trust response explains the difficulty it faced in attending a mediation session in person, and difficulty attending remote sessions due to apparent travel conflicts. The response acknowledges the Court’s prior orders, and represents an interest in seeking resolution on the merits of the

objection. The Court finds a decision on the Cary Trust’s response to be a very close call, but the Court concludes it shows some good faith effort to comply with the Settlement Track provisions. The Court also notes that deadlines and obligations in the Hearing Track schedule will be enforced with less leniency.

In the context of the Settlement Track proceedings, each of their efforts to participate, and their timely responses to the Show Cause Order, the Court concludes the responses of Motta, Bartell, Hofschulte, Alexander, and the Cary Trust each show good cause not to dismiss each of their objections. The objections will remain active.

The Court also notes that in a number of situations a single objection was filed by multiple parties, often by spouses. The Court is not dismissing the objections where only one spouse or a single representative of a multi-party objection attended a mediation session.

With respect to the remaining parties identified in the Show Cause Order, no response was received, nor is there any basis for the Court to conclude anyone representing a filed objection attended.
