Pursuant to its authority under Rule 17, W.R.Adj.R. Under Rule 17(a) and § 85-2-233(5)(b), MCA, the Court accepts each stipulation and finds they provide good cause to dismiss the respective objections.

On December 12, 2023, David H. Snyder filed an objection. (Doc. 1553.00). The objection deadline set in this case, as extended by the December 2, 2022 Order Extending Objection Deadline, was February 9, 2023. (Doc. 240.00). The Court clarifies for the record that this objection was filed late and is not accepted.

THEREFORE it is ORDERED that each objection identified on the tables in this Order, and those objections identified as late, is DISMISSED The Master Service List on the Court's website shall be updated to reflect this Order.
