**NOTICE OF PREHEARING CONFERENCE INSTRUCTIONS

(Lake County Hearings)**

Pursuant to Case Management Order No. 6 (“CMO-6”), as amended and supplemented, the Court provides the following instructions and access information for the April 25, 2025, prehearing conferences, which will commence at 10:00 A.M. Mountain Time.

1. A separate prehearing conference will be conducted for each hearing scheduled for the week of April 30, 2025, in Polson. The conferences will take place sequentially, meaning at the conclusion of one conference, the next conference will begin. All parties or their legal counsel who are parties to any of the Polson hearings shall attend the conferences. As a party’s prehearing conference concludes, they may be excused from the call.

2. As specified in CMO-6, on or before April 22, 2025, each party to any of the Polson hearings shall file a proposed prehearing order. The Compact Parties shall file separate proposed prehearing orders for each separate Request for Hearing that remains pending. 3. The Polson hearings will take place in the Lake County Courthouse located at 106 4th Ave E, Polson, Montana.
