COURT MINUTES AND ORDER SETTING DEADLINES

Pursuant to the Court’s Case Management Order No. 9 (“CMO-9”) dated May 16, 2025 (Doc. 2602.00), a Zoom conference was held on June 5, 2025. The purpose of the conference was to set post-hearing briefing deadlines and to answer questions about post-hearing briefing.
