COURT MINUTES AND ORDER VACATING DEADLINES

Pursuant to the Court's Order dated June 5, 2025 (Doc. 2606.00), a Zoom conference was held on June 26, 2025. The purpose of the conference was to discuss the post-hearing briefing deadlines in light of unanticipated delays in receiving the transcript for the evidentiary hearings. Based on the discussion and unopposed oral motion from the Compact Parties, the Court concludes it prudent to vacate the current briefing deadlines and to defer resetting them until after the transcripts have been received. To that end, this Order sets a status conference to discuss revised briefing deadlines.

Therefore, it is ORDERED:

1. The Compact Parties' motion to vacate the post-hearing briefing deadlines is GRANTED.
