

MINUTES OF THE MEETING
APPROPRIATIONS COMMITTEE
MONTANA STATE
HOUSE OF REPRESENTATIVES

January 11, 1985

The meeting of the Appropriations Committee was called to order by Chairman Bardanoue on January 11, 1985 at 1:35 p.m. in Room 104 of the State Capitol.

ROLL CALL: All members were present.

(Tape 1:B:124)

HOUSE BILL 123: "AN ACT TO REQUIRE THAT GRANT PROPOSALS FOR CULTURAL AND AESTHETIC PROJECTS BE HEARD BY THE LEGISLATIVE APPROPRIATIONS SUBCOMMITTEE ON LONG-RANGE PLANNING; AMENDING SECTION 22-2-304, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

Representative Thoft (150), sponsor of the bill, said his bill will move the hearings for cultural and aesthetic projects from the Institutions subcommittee to the Long-Range Planning subcommittee. The purpose of the bill is to balance the workload of subcommittees.

Representative Waldron (169) said if the law is going to be changed to switch hearings on cultural and aesthetic grants to another subcommittee, a more appropriate approach may be to delete the section in the law which requires grant proposals be heard in a specific subcommittee, thus giving more flexibility to subcommittee assignments.

Representative Thoft (198) said the people who prepare grant proposals may prefer to know which subcommittee will hear the proposals; therefore, he will oppose an amendment to the bill.

E X E C U T I V E A C T I O N :

Representative Moore (225) made a motion that House Bill 123 DO PASS. The motion was seconded.

Representative Waldron (232) said he just now stepped out of the meeting and talked with representatives of the Arts Council who said they would like to be treated the same as other grant applicants and not have the law designate which subcommittee will hear proposals.

Representative Waldron (248) made a substitute motion that House Bill 123 be amended as follows:

A roll call vote was taken, with 12 members voting yes and Representatives Donaldson, Ernst, Manuel, Menahan, Moore, Rehberg, Swift, and Thoft voting no. The motion carried.

Representative Moore (326) made a motion that House Bill 123, AS AMENDED DO PASS. A roll call vote was taken with 17 members voting yes and Representatives Moore, Swift and Thoft voting no. The motion carried. (Representative Moore voted against his own motion.)

Adjourn: The meeting adjourned at 1:55 p.m.
